What is the purpose of this update?

This document tells you how the Nikko AM NZ Corporate Bond Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The Fund aims to outperform the Bloomberg NZBond Credit 0+ Year Index by 0.70% p.a. over a rolling three year period before fees, expenses and taxes. The fund aims to provide investors with regular income by constructing an actively managed investment portfolio of New Zealand bonds, deposits and cash whilst preserving the capital value.

What are the risks of investing? Risk indicator for Nikko AM NZ Corporate Bond Fund:



In the current year ending 31 March 2022, it is expected that total fund charges will decrease. The Manager's basic fee was reduced from 0.79% to 0.70% on 1 April 2021. For the twelve months ended 31 December 2021, the fee was 0.72%.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds).

Small differences in fees and charges can have a big impact on your investment over the long term.


Simon had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Simon incurred a loss after fund charges were deducted of -\$451 (that is -4.51% of his initial \$10,000). Simon also paid no other charges. This gives Simon a total loss after tax of -\$328 for the year.²
