#### What is the purpose of this update?



Nikko AM is relying on the Financial Markets Conduct (Market Index) Exemption Notice 2018 and have created a composite index in order to calculate the market index annual return. **Donated management fee**: As noted above, we charge an annual management fee to the Fund. However, this fee is not retained by us, instead it is fully donated to the charity each month. There are no charges for underlying investment costs – no Supervisor's fee and administration costs (such as audit fees, registry services, unit pricing and accounting services).

#### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Simon had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Simon received a return after fund charges were deducted of \$253 (that is 2.53% of his initial \$10,000). Simon also paid no other charges. This gives Simon a total return after tax of \$253 for the year.<sup>2</sup>

In the example above, the returns made by Simon's investment are retained by the fund and/or donated to charity.




